A NOTE FROM THE SUPERINTENDENT

As part of the recent bond issue the entry of the Ag building was completed over the summer. The restrooms are now ADA compliant with access from the classroom, which enables proper supervision. The entry now has no wasted space and the custodial closet has been enlarged.

Round and rectangular replacement tables were purchased for both cafeterias.

The middle school boys' and girls' bathroom renovation will begin in November. They will both be ADA compliant and will get a complete makeover.

Fayette's local operating revenue has outpaced state operating revenue for several years now, but the difference between the two has grown considerably. Local revenue is expected to be 52% of the district operating budget this year and state revenue is expected to be 34% of the district operating budget. Local revenue is received by the district in January. State revenue payments are received monthly and are of varying amounts each time.

The district will be taking out two TANs or Tax Anticipatory Notes in October and November and will need to repay those loans with interest upon receiving the local tax check in January as required by

Historically, the district has had to obtain TANs when the percent of fund balance at the end of the year drops below 15%. At that point, there is not enough cash flow to pay bills through the end of the year until the local tax monies are received.

The district has utilized cost savings measures over the last six years to address the financial shortfalls. Over twenty positions have been eliminated mainly through attrition, when a person leaving the district

was not replaced.

We welcomed the following new staff members this We have renegotiated contract services and outsourced services as cost saving measures and have cut back on supply budgets throughout all departments.

> The only control the district has over its budget is expenditures. The district cannot control enrollment, attendance, needs of students, or the state budget, which all impact revenue. When revenues do not cover current expenditures, deficit spending occurs. We cannot cut mandatory programming. We are now faced with determining what additional cuts can be made that will have the least impact on our programming which directly impacts our students. We pride ourselves in being responsive to student needs and have programs in place that have addressed those needs and enabled students performing below grade level to attain grade level. Daly Elementary is no longer identified as a Focus School due to the professional development and training in which staff has participated in order to provide the cutting edge, high quality instruction it has taken to address the issues identified in a Focus School

> The district will place another levy issue on the April 2019 ballot in order to increase operating funds. A levy campaign committee has been formed and will share information in a variety of formats after the first of the year. NOTIFICATION OF DESTRUCTION **OF STUDENT** SPECIAL EDUCATION RECORDS

In accordance with the state and federal regulations implementing the Individuals with Disabilities Education Act (IDEA), this is to inform you of our intent to destroy personally identifiable information related to special education services that were in effect prior to June 30, 2009.

If you wish to maintain this information for your personal records, you need to notify us upon receipt of this notice; otherwise, the information will be destroyed on January 31, 2019.

Please be advised that the records may be needed by the student or the parent(s) for social security benefits or other purposes. Records to be destroyed are as follows: Individualized Education Programs (IEPs); Evaluation Reports; Test Protocols; Notifications of Meetings; Notices of Action; Review of Existing Data; All other personally identifiable information within the Special Education file*

The reason for destruction of the above listed items is because they are no longer needed to provide educational services as it has been more than three (3) years since this individual has received special education services at Fayette High School.

*The district may maintain a permanent record, without time limitation, of a student's name, address and phone number, his/her grades, attendance record, classes attended, grade level completed, and year completed.

The school is required to maintain records for a minimum of three (3) years from the date the child no longer received special education and related services.

THE CURRICULUM CORNER

What I love about the beginning of a new school year is the limitless potential it brings. The start of a school year represents a new chance to bring positive change to the lives of our students and their families. We strive to build relationships with our students so that they know that they are valued, cared for, and that we believe in them. We are committed to meeting the educational needs of every student.

A variety of services are available in our schools to assist those whose educational needs require supports beyond what is typically provided within the regular classroom. Recently, we entered into a partnership with Burrell Behavioral Health. Burrell will offer on-site mental health services for students who qualify for the school-based services program.

We focus on student learning, working collaboratively and holding ourselves accountable for results which fuel continuous improvement. On professional development days, teachers spend time reviewing data and engaging in activities to build knowledge in the use of technology and instructional processes to positively impact student learning. According to John Hattie's research, two of the most effective strategies for positive impact on student achievement are formative assessment and teacher-student relationships. As a district, those are related to two of the four overall teaching standards that we focus on in

our classrooms- the effect of instruction on individual and class learning (formative assessment) and establishing a secure and kind classroom community.

As always, the bulk of our state grade card, the Annual Performance Report (APR), will be based on student scores on the MAP tests. This year new assessments were administered, and there have been delays in score reporting. Test results from the spring tests will not be available until the end of November and the APR will not be released until February.

Obviously the change in assessment is going to have an impact on test scores across the state, it just remains to be seen how much of an impact it will make.

As we near the Thanksgiving holiday, it's a great opportunity to focus on unity, appreciation, and gratefulness. We constantly face challenges and divisiveness in our world, but there is common ground we all share, our mission- to educate all students to be ethical, successful citizens.

We are extremely fortunate to be surrounded by promising students, dedicated staff and a supportive community which assist us in making that mission possible.

SPECIAL EDUCATION THERE IS A PROCESS TO OBTAIN AN IEP OR 504 DESIGNATION

To qualify for a specialized plan under Section 504, a child will need to have a disability or impairment that "substantially" limits or reduces their ability to access classroom learning. A referral can be made by a parent or teacher to initiate the 504 evaluation process. If your child is found eligible, the district will initiate a 504 plan to identify accommodations that your child needs to access the general education curriculum.

Accommodations may include: frequent feedback from the teacher; preferred seating arrangements; or extended time to take tests.

If your child requires specialized instruction, they may qualify for an IEP or Individualized Education Plan. A referral for special education services can be made by a parent or educational agency. Within thirty days of the initial referral, a review of existing data (RED) will be conducted to collect information. After the RED is completed, a determination may be made to evaluate the child. The evaluation could include testing which would be conducted over a sixty day period. Based upon eligibility determination, an IEP may be developed to address your child's educational needs.

Board Member Candidate Information

The school board member terms of Michelle Howell and Eric McSwain are ending and are up for election in April. Candidate filing for the April 2, 2019 school board election begins at 8:00 a.m. on December 11, 2018, and closes at 5:00 p.m. on January 15, 2019. Those interested in running for the school board need to sign up at the Fayette R-III School District Central Office * 705 Lucky St. * Fayette, MO 65248. * 660-248-2153. Information will be available at the time of registration. Additional resources are available through the MSBA website at www.msbanet.org.

To run for the local school board, you must meet the following qualifications: (1) must be a citizen of the United States, (2) must be a resident taxpayer of the district, (3) must be a resident of Missouri within one year and (4) must be at least 24 years old.

Successfully elected board members are further required to complete sixteen hours of orientation and training within one year of their election (RSMo.162.203). This requirement includes both seat time and online.

School board members serve three year terms. Meetings are held once a month with additional meetings scheduled when necessary. Fayette school board members are active in the community, attend school events, serve on district committees, and attend annual MSBA conferences, regional meetings and legislative forums to stay abreast of the issues impacting public education. The Board follows an operating protocol, code of ethics, and a confidentiality agreement.
